Registration:

- **ALL VENDORS**, regardless of vending location, must check in at the Vendor Registration trailer at the marina (13 S. State St.).

Vendor Guidelines:

- Please follow these basic guidelines:
 - 1. **NO** stakes can be used to secure your tent in the pavement.
 - 2. Set-up time: **Thursday, June 27, at noon no early set-up.** You must be on location no later than 3:00 pm on Friday, June 28.
 - 3. Hours of operation: Non-Food Vendors - Thursday noon through Saturday evening. Food Vendors – Thursday noon through Saturday evening only. Food vendors must comply with all Health Department guidelines. Food vending spaces are limited. 2023 food vendors will have the first opportunity to vend in 2024. Local non-profits and local restaurants: You no longer need a permit from the City of St. Ignace. A Health Department permit is only needed if you are vending outside at your normal food serving location. If you would like to vend in a place other than your place of business you would need to complete and return the enclosed vendor form.
 - 4. If you are vending on private property, you must have a letter of permission from the land owner.
 - 5. You are responsible for clean-up of your area upon departing.
 - 6. Dumpsters are available on-site. Boxes MUST be broken down.
